I, Jennifer M. Keough, declare as follows:

I am the Chief Executive Officer (CEO) and President of JND Legal 1. Administration LLC ("JND"). This Declaration is based on my personal knowledge and information provided to me by Class Counsel and experienced JND employees and, if called upon to do so, I could and would testify competently thereto.

2. I previously filed a Declaration in Support of Motion for Preliminary Approval of Class Action Settlement and Direction of Notice under Rule 23(E), filed May 13, 2022, Docket No. 944-2 ("Preliminary Approval Declaration"), a Declaration Regarding Compliance with the Class Action Fairness Act, 28 USC § 1715, filed June 7, 2022, Docket No. 950-1, and a Declaration Regarding Class Notice, filed July 29, 2022, Docket No. 959 ("Class Notice Declaration"). This Declaration is being filed to further update the Court regarding Class Notice implementation and Settlement administration.

MAIL NOTICE

3. Per Section 8.a. of the Preliminary Approval Order, on July 22, 2022, JND mailed the Court-approved summary version of the Fisher Class Settlement Notice with the Fisher Class Claim Form ("Fisher Class Notice Packet") by USPS First Class Mail, postage pre-paid, to 1,994 Fisher Class Members on the Fisher Notice List and 37 Fisher Organizations and Port Contacts identified by Class Counsel, consistent with Paragraph 38 of my Preliminary Approval Declaration.¹

4. As of September 1, 2022, 197 Fisher Class Notice Packets have been returned to JND as undeliverable. JND has re-mailed 4 Fisher Class Notice Packets to an updated address provided by the USPS. In addition, JND performed advanced address research for

the 193 undeliverables without a USPS updated address and re-mailed 73 Fisher Class Notice Packets to an updated address.

5. Per Section 8.a. of the Preliminary Approval Order, on July 22, 2022, JND mailed the summary version of the Property Class Settlement Notice with the Property Class Claim Form ("Property Class Notice Packet") by USPS First Class Mail, postage pre-paid, to 13,341 unique addresses in total, including property addresses and available mailing addresses (if different from property addresses) for the 8,061 Property Class Members on the Property Class Notice List identified by unique assessor's parcel number as detailed in Paragraph 4 of my Class Notice Declaration. Additionally, on July 26, 2022, JND mailed a Property Class Notice Packet by USPS First Class Mail, postage pre-paid, to 14 current owners of Included Properties because information regarding owners of those Included Properties was unavailable as of May 19, 2015.

6. As of September 1, 2022, 1,215 Property Class Notice Packets have been returned to JND as undeliverable. 173 Property Class Notice Packets were forwarded by the USPS to an updated address. In addition, JND performed advanced address research for 1,215 undeliverables without a USPS updated address and re-mailed 191 Property Class Notice Packets to an updated address.

7. As of August 25, 2022, of the 1,994 Fisher Class Members sent direct Mail Notice, 1,866 or 94% were deemed delivered and 128 or 6% deemed undeliverable. Of the 8,061 unique assessor's parcel numbers identified in the Property Notice List sent direct Mail Notice, 7,739 or 96% were deemed delivered and 322 or 4% were deemed undeliverable. The Federal Judicial Center's *Judges' Class Action Notice and Claims Process Checklist and Plain Language Guide* ("FJC Checklist") considers a Notice Plan with a high reach (above 70%) effective. This distribution rate is therefore consistent with typical benchmarks for successful notice programs.

8. Per Paragraph 26 of my Preliminary Approval Declaration, JND will continue to track all notices returned undeliverable by USPS and will promptly re-mail notices that are returned with a forwarding address. In addition, JND will also take reasonable efforts to research and determine if it is possible to reach a Class Member for whom a notice is returned without a forwarding address, either by mailing to a more recent address or using available advanced address search tools to identify a new mailing address where the Class Member may be reached.

SETTLEMENT WEBSITE AND EMAIL ADDRESS

Pursuant to Section 8.c. of the Preliminary Approval Order, on July 11, 2022, 9. JND established an informational Settlement website, www.PlainsOilSpillSettlement.com ("Settlement Website"), that allows Class Members to learn more about the litigation and Settlement. The "Home" page provides a summary of the proposed Settlement, key dates, and an overview of legal rights and options. The "File a Claim" page allows Class Members to file claims online, through the October 31, 2022 claims deadline, and also allows Class Members to download, in PDF format, copies of the Fisher Class and Property Class Claim Forms. An "Important Documents" page provides, in PDF format, copies of important Court documents including the operative Second Amended Complaint, Settlement Agreement, Order Granting Preliminary Approval of Proposed Settlement, and the [Proposed] Plans of Distribution for the Fisher Class and Property Class. The "FAQ" page provides answers to frequently asked questions. There is also a separate "Key Dates" page noting important Settlement deadlines and a "Contact Us" page detailing how JND can be reached by email, toll-free telephone, and mail. In addition, there are separate pages to download the Notice in Spanish, Vietnamese, and Chinese.

10. As of September 1, 2022, there were 12,024 total views of the Settlement Website pages and documents and 3,780 unique visitors to the Settlement Website. JND will continue to maintain the Settlement Website throughout the Settlement administration process.

11. JND also maintains an email address, <u>info@PlainsOilSpillSettlement.com</u> ("Settlement Email Address"), that permits Class Members and other individuals to submit e-mail inquiries to JND. As of September 1, 2022, JND has handled 244 email communications received to the Settlement Email Address. JND will continue to maintain the Settlement Email Address throughout the Settlement administration process.

TOLL-FREE NUMBER

12. On July 22, 2022, JND established a Settlement-specific dedicated toll-free Interactive Voice Response ("IVR") number, 1-844-202-9486, for Class Members and other individuals to call for additional information.

13. As of September 1, 2022, JND has received 442 calls to the IVR and JND's Claimant Assistance Center team has handled 185 live calls. JND will continue to maintain the toll-free IVR number and assist Class Members throughout the Settlement administration process.

CLAIMS PROCESS

14. Fisher and Property Class Settlement Email and Mail notices informed Class Members that a Fisher or Property Class Claim Form must be submitted to participate in the Settlement, and that all claims must be received through the Settlement website or postmarked no later than October 31, 2022.

15. The Settlement Website allows Class Members to file Fisher Class and Property Class Claim Forms online and download both Claim Forms in PDF format to

submit by mail. The claims administration program was opened at the end of July and the online portal for submission of claims went live on August 24, 2022. JND has received completed claim forms, both through the mail and the online portal.

16. In addition, JND personnel attended the August 30, 2022 web seminar hosted by the Commercial Fishermen of Santa Barbara ("CFSB"), which is described in further detail in Class Counsel's papers.

17. JND will process Fisher and Property Class claims to confirm eligibility and claim deficiencies, perform quality assurance procedures, conduct claim de-duplication and claim validation, and solicit feedback from the parties.

18. JND will continue to administer the Settlement through all phases of Settlement Administration, as required by the Settlement Agreement, Preliminary Approval Order, and pursuant to any future Orders of this Court.
